Top Vendor Wedding Awards (TWA) – Terms, Conditions & Disclaimer

1. Membership

- 1.1 TWA Membership is valid from the date of payment for a period of six (6) months.
- 1.2 Membership fees are strictly non-refundable.
- 1.3 Members must be operating a business or be employed by a business within South Africa.
- 1.4 Membership does not guarantee entry into the awards.

2. Entries & Participation

- 2.1 All participants are subject to a selection process. Categories are assigned based on TWA's evaluation criteria.
- 2.2 TWA reserves the right to reject or refuse members and/or entrants at its sole discretion.
- 2.3 In the event that a category receives fewer than five (5) entries, TWA reserves the right to close that category. Participants may be offered an alternative category or free entry into the following year's awards.
- 2.4 All entries must be submitted by the official closing date. Late submissions will not be accepted.
- 2.5 Entries MUST contain the correct number of images as specified in the entry form. Participants are responsible for carefully reviewing all entry requirements prior to submission.

3. Submission Requirements

- 3.1 All submissions must be original, genuine work created by the participant.
- 3.2 Participants must own all rights to submitted content or have obtained full permission and consent from the rightful owner(s).
- 3.3 Submissions must accurately and truthfully represent the work and must not be altered in a way that misrepresents the final result.
- 3.4 Only work completed during 2025 and 2026 will be accepted.
- 3.5 No hard copy entries will be accepted. All submissions must be digital.

4. Image & Content Rules (IMPORTANT)

4.1 No images may be branded in any way.

4.2 Images may not include:

- Company names or logos
- File names that reflect a company name
- Any person representing the company (e.g., staff in branded attire)
- 4.3 Any submission that does not comply with these requirements will be disqualified.

5. Judging & Results

5.1 All entries will be reviewed and judged by a selected panel.

5.2 The judging panel's decisions are final and binding.

5.3 Winners will be announced after the judging period and notified via email, with results also published online.

6. Legal & Compliance

6.1 Participants must notify TWA if any submitted work becomes subject to legal action.

6.2 TWA reserves the right to take appropriate action to avoid legal or reputational risk.

6.3 All content must comply with applicable laws and regulations.

7. Content Standards

7.1 Submissions must not contain any content that is:

- Offensive, explicit, discriminatory, or illegal
- In violation of intellectual property or privacy rights
- Promoting violence, hatred, or discrimination
- Sexually explicit or inappropriate
- Misleading, false, or defamatory
- Depicting or encouraging illegal or harmful activities

7.2 TWA reserves the right to remove or disqualify any content that does not meet these standards.

8. Privacy

8.1 Any personal information collected will be used solely for the administration of the platform and awards.

9. Events & Platform Use

9.1 TWA operates as a national platform within South Africa.

9.2 Networking sessions and annual celebrations may be held in any province.

9.3 The format, frequency, and structure of events are at TWA's sole discretion.

10.1 While every effort is made to ensure fairness and transparency, TWA does not guarantee participation, nomination, finalist placement, or winning status.

10.2 TWA shall not be held liable for any loss, damage, or claims arising from participation in the awards or use of the platform.
